It participates in six of seven key semiconductor process steps, supplying high purity specialty process gas, cleaners and etchants, slurries, organosilanes and organometallics deposition films, and equipment. Versum, headquartered in Tempe, Arizona, has approximately 1,900 employees, 14 manufacturing and six research and development facilities in the Americas and Asia.
